You are receiving this letter because public records show you own property or live in the area where AEP Ohio representatives plan to upgrade the local power grid. I'm writing to provide an update on the Hillsboro-Lebanon Transmission Line Rebuild Project.

We announced the Hillsboro-Lebanon Transmission Line Rebuild Project in August. The project involves:

- Replacing two 17-mile long paralleling power lines and combining them into a single line located within the existing right-of-way between Hillsboro and Blanchester
- Rebuilding an approximate 19-mile power line between Blanchester and Lebanon
- Upgrading the Middleboro Substation near Blanchester

We have filed the 19-mile section of this project with the Ohio Power Siting Board (OPSB) as the Hutchings Tap-Middleboro Switch 138kV Line and Middleboro Switch-Clinton County (Duke) 138kV Line Project, Case No. 19-1941-EL-BLN. **Please see Page 3 of this document for key regulatory information associated with this project.**

The upgrades strengthen the power grid and improve electric reliability. We expect construction to begin early next year and conclude at the end of the year.


