JOINT MOTION FOR A CONTINUANCE AND REQUEST FOR EXPEDITED RULING

Pursuant to Rule 4901-1-13, Ohio Administrative Code, the Retail Energy Supply Association, Direct Energy Business Marketing, LLC, Direct Energy Services, LLC, Interstate Gas Supply, Inc., Dominion Energy Solutions, Inc., The East Ohio Gas Company d/b/a Dominion Energy Ohio and Staff of the Public Utilities Commission of Ohio ("the Joint Movants") respectfully ask the Commission for a short continuance of the hearing from December 3, 2019 to December 17, 2019.
