WHEREAS, That resolution (Res 19-73) resolved that "any new applications under the 2011 Alternative Energy Zone must be submitted to the proper authorities by June 30, 2019. At that time, the Alternative Energy Zone will rescind to new applications, thus sunsetting the Alternative Energy Zone program in Seneca County, and

WHEREAS, The same resolution (Res 19-73) further states that; Although the Seneca Wind and Republic Wind projects are accepted under the 2011 AEZ agreement, if they must resubmit their application, they no longer be grandfathered under the agreement...", and

WHEREAS, This Board supplemented and amended Resolution 19-73 by subsequent resolution 19-159, and

WHEREAS, the Seneca Wind LLC Application before the Ohio Power Siting Board was dismissed by Seneca Wind on August 9, 2019, and be it

RESOLVED, that any new application filed by Seneca Wind LLC with the Ohio Power Siting Board shall not be part of or subject to or receive any benefits of the 2011 Alternative Energy Zone and shall not qualify as a qualified energy project under ORC Section 5727.75. Further resolved, that the Ohio Development Services Agency shall immediately rescind and cancel the Ohio Qualified Energy Project Tax Exemption Certificate for Seneca Wind LLC dated August 31, 2018, and

RESOLVED, copies of this resolution shall be sent to the Ohio Development Services Agency, The Ohio Power Siting Board, Public Utilities Commission of Ohio, Seneca County Prosecuting Attorney, Seneca County Auditor, Seneca County Treasurer, Tax Commissioner and Seneca Wind LLC, now therefore, and be it further

RESOLVED, that it is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Board, and that all deliberations of this Board, and any of its committees that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements.
