On February 22, 2018, the Ohio Rail Development Commission (ORDC) authorized funding for Norfolk Southern Railway to upgrade the active warning devices at Union Avenue DOT#503-013S, in Stark County, Ohio. The crossing was surveyed, on August 11, 2017, and found to warrant the upgrades.

On November 28, 2018, the Commission approved the project and ordered completion by November 28, 2019.

On November 20, 2019, NS filed for an extension until December 28, 2019. In the request, NS states construction commenced on November 11, 2019. Crews will need 20 gang days to complete construction.

ORDC and Staff reviewed this project. Based on staff's review of the extension request and communications with ORDC, Staff does not believe thirty (30) days is sufficient to complete the project. As such, staff recommends denial of the extension request.
