**Re:** PUCO Case No. 18-1615-RR-FED- In the Matter of a Request for the Installation of Active Warning Devices at the Norfolk Southern Railway Crossing, Norwood Avenue DOT#508-925U, in Lucas County, Ohio.

On February 12, 2018, the Ohio Rail Development Commission (ORDC) authorized funding for Norfolk Southern Railway to install active warning devices at Norwood Avenue DOT#508-925U, in Lucas County, Ohio. The crossing was surveyed, on October 17, 2017, and found to warrant the upgrade.

On November 28, 2018, the Commission approved the project and ordered completion by November 28, 2019.

On November 20, 2019, NS filed for an extension until December 28, 2019. In the request, NS states construction commenced on November 11, 2019. Crews will need 28 gang days to complete construction.

ORDC and Staff reviewed this project. Based on staff's review of the extension request and communications with ORDC, Staff does not believe thirty (30) days is sufficient to complete the project. As such, staff recommends denial of the extension request.
