We have several restaurant franchisee clients that have expanded operations into the state of Ohio that have requested our services.

B-2 Exhibit B-2 "Experience & Plans,"

Rob Yedor, our President is the person who deals directly with all customer initiatives, contracts, bids and follow up services. Rob's experience is spelled out in A-13 and he continues to attend seminars, online classrooms and offers his customers a deeper understanding of market conditions and contract procurement. We do not offer billing services, as that is handled by the local utility and the independent provider. All contracts are drafted by the direct provider, sent to Rob for approval before submitting to the client. Rob gets the contract back from the customer, makes sure it is filled out correctly then files it back to the provider. Rob follows up with the client after services are rendered to make sure all aspects of the contract are being fulfilled.

Since 2009, Rob Yedor, our President, has provided electric & gas procurement advisory services for over 100 companies comprising nearly 1000 locations in deregulated states across America. Rob will first look over customer utility bills from every location that company has so he can analyze usage, peak load requirements and cost per kwh. If that company is already under contract with another independent provider, Rob will compare the contract with the current billing structure to make sure his provider is fulfilling its obligations. Invision Energy contracts approximately 10,000 megawatt hours annually.
