MOTION FOR EXTENSION

Pursuant to Ohio Administrative Code Rule 4901:1-27-09(B), CQI Associates, LLC (“CQI”) seeks an extension of Certificate No. 16-1040E (2), which was issued in Case No. 15-2079-EL-AGG with an expiration date of January 15, 2020. Due to the press of other business, CQI was not able to file its renewal application thirty days prior to the expiration date of its certificate as required by Ohio Admin. Code 4901:1-24-09(A). CQI respectfully requests a motion for an extension of the January 15, 2020 expiration date for its certificate pursuant to Ohio Admin. Code 4901:1-24-09(B). CQI filed its Renewal Application on January 13, 2020 which was two calendar days prior to the January 15, 2020 expiration date. In support of the application, CQI respectfully requests that Certificate No. 16-1040E (2) be automatically extended from January 15, 2020 until February 15, 2020 or until the date that the renewal certificate is issued.

WHEREFORE, CQI respectfully requests that Certificate No. 16-1040E (2) be automatically extended to February 15, 2020 or until a new certificate is issued and that the Commission authorize it to continue to operate during the pendency of the renewal application review.

**MEMORANDUM IN SUPPORT OF
MOTION FOR EXTENSION**

Due to the press of other business, CQI did not meet the December 16, 2019, filing date deadline for its Renewal Application in Case No. 15-2079-EL-AGG. CQI sincerely apologizes for the delay and emphasizes its desire to continue to serve customers in Ohio. A Renewal Application was filed on January 13, 2020, however a Motion for Extension was mistakenly not filed along with it. CQI is filing this motion pursuant to O.A.C. 4901:1-24-09(B) as it previously should have to enable an extension during the renewal review which is ongoing.

Ohio Administrative Code Rule 4901:1-24-09(B) provides that a motion requesting an extension of a certificate will be deemed automatically approved (unless ruled otherwise by the Commission or an Attorney Examiner within three business days), if a renewal application is filed fewer than thirty calendar days prior to the expiration date of the certificate but no later than the expiration date. CQI submits that it has met the criteria and respectfully requests an automatic extension of the expiration date of Certificate No. 16-1040E (2) issued in Case No. 15-2079-EL-AGG until such time as a new certificate is issued.
