Vectren Energy Delivery of Ohio, Inc. ("VEDO"), a CenterPoint Energy Company, seeks approval to revise its Unaccounted For Gas Percentage shown on P.U.C.O. No. 4, Sheet No. 54, to be effective on April 1, 2020 to coincide with VEDO's Standard Choice Offer ("SCO") period, based on the calculation of system unaccounted for percentage shown on Exhibit C-3, attached hereto. This proposal is made pursuant to the requirement of Sheet No. 54 which states that "[t]he Unaccounted For Gas Percentage . . . shall be adjusted periodically by Company, through updating of this Sheet No. 54, in accordance with the procedures approved by the Commission in Case No. 18-0298-GA-AIR¹, to reflect any changes in the system unaccounted for percentage."

VEDO's Tariff for Gas Service, P.U.C.O. No. 4, Sheet No. 54 provides that "[t]he Unaccounted For Gas Percentage . . . shall be adjusted periodically by Company, through updating of this Sheet No. 54, in accordance with the procedures approved by the Commission in Case No. 18-0298-GA-AIR, to reflect any changes in the system unaccounted for percentage." The calculation on the attached document demonstrates that the system unaccounted for percentage is now 1.1%. Consistent with the requirement in Sheet No. 54, VEDO, therefore requests approval to adjust its Unaccounted for Gas Percentage to 1.1%.

The October 1, 2018 PUCO Staff Report in Case No. 18-0298-GA-AIR (page 23) recommended approval of the Company's proposal to automatically approve changes to the Company's Unaccounted for Gas Percentage set forth in Tariff Sheet No. 54 following a review period of 45 days. The August 28, 2019 Opinion and Order (page 26) in Case No. 18-0298-GA-AIR, et al., adopts the Staff report in regards to all rates, terms, and conditions, unless specifically provided for in the Stipulation. VEDO transportation customers must be notified in advance of the first day of the month of any change in the Unaccounted for Gas Percentage in order to adjust their nominations to be inclusive of the new UAFG Percentage for the month. Therefore, the Company is filing the UAFG application February 3, 2020 to allow the 45 day review period to be fulfilled March 19, 2020. The Revised Tariff Sheet No. 54 with an Issue date of March 20, 2020 and an effective date of April 1, 2020 will allow the Company to implement the new unaccounted for gas percentage effective on April 1, 2020 to coincide with VEDO's Standard Choice Offer ("SCO") period.
