# FIRELANDS WIND, LLC'S RESPONSE TO THE SEVENTH DATA REQUEST FROM THE STAFF OF THE OHIO POWER SITING BOARD

On January 31, 2019, as supplemented on March 18, 2019, April 11, 2019, July 10, 2019, and September 12, 2019, as revised on October 4, 2019, Firelands Wind, LLC ("Applicant") filed an application ("Application") with the Ohio Power Siting Board ("OPSB") proposing to construct a wind-powered electric generation facility in Huron and Erie Counties, Ohio ("Project").

On February 4, 6, and 10, 2020, the Staff of the OPSB ("OPSB Staff") provided the Applicant with OPSB Staff's Seventh Data Request. Now comes the Applicant providing the following responses to the Seventh Data Request from the OPSB Staff.

**Response:** The Applicant is in the process of finalizing the responses to this inquiry and will be providing the response to OPSB Staff as soon as it is complete.

# 2. Is the Emerson Creek Wind project a qualified energy project?

**Response:** At this time, the Emerson Creek Wind project is not a qualified energy project ("QEP") as defined in Ohio Revised Code Section 5727.75 and does not currently have a payment in lieu of taxes ("PILOT") exemption. However, the Applicant may reapply for QEP certification to the Ohio Development Services Agency in the future.

#### 3. If not (a-d):

a. If not, does Firelands Wind intend to provide or facilitate training for fire and emergency responders for response to emergency situations related to the project and equip the fire and emergency responders with proper equipment as reasonably required to enable them to respond to such emergency situations?

**Response:** The Applicant has communicated with and will coordinate with local fire and emergency responders to provide training through in-person meetings and through safety drills with emergency services where "mock" events are practiced. If additional equipment is reasonably required to enable fire and emergency responders to properly respond to emergency situations at the project as outlined in the Emergency Action Plan, Applicant will either supply the necessary funds or equipment to the local fire and emergency responders.

# b. Does Firelands Wind intend to hire a certain percentage of Ohio domiciled employees for construction?

**Response:** The Applicant expects that a significant percentage of Ohio-domiciled workers will be employed for construction and is seeking to coordinate with local contractors to provide opportunities for local Ohio-domiciled workers. The General Contractor will have final say over subcontractors, but the Applicant

expects that a significant portion of the employment opportunities for this project will go to Ohio-domiciled workers. The Applicant has reached out locally to begin a list of local contractors interested in being involved in the construction process and that information will be shared with the General Contractor upon selection.

#### c. Has or will an updated JEDI model study be conducted?

**Response:** An updated JEDI model study will be conducted to reflect a non-PILOT scenario. The study will be provided to OPSB Staff when it is complete.

#### d. What is the rate of taxation that Firelands will be subject to?

**Response:** The rate of taxation will be the tangible personal property and real property tax rates at the facility locations.
