Dear Ms. McNeal:

On February 27, 2020, FirstEnergy Solutions Corp. (“FES”), a certified competitive retail electric service (“CRES”) provider in Ohio, emerged from Chapter 11 bankruptcy under a new name – Energy Harbor, LLC (“Energy Harbor”). Accordingly, as of the date of emergence, FES shall operate under the Energy Harbor name.

As explained in responses filed in this docket on May 4, 2018, April 22, 2019, and November 19, 2019, Energy Harbor (then operating as FES) assured the Commission, its customers, and other relevant stakeholders that it would continue to operate in the ordinary course of business despite filing for Chapter 11 bankruptcy. While in bankruptcy, FES continued its customer programs/services in the ordinary course, honored all obligations related to the customer programs/services, and continued to enter into new customer agreements and enroll customers as it has over the last two decades. Further, FES continued to meet all of its obligations to provide collateral or other financial guarantees to the electric distribution utilities (“EDUs”) in Ohio and regional transmission organizations (“RTOs”) to ensure that sufficient collateral or other financial guarantees or other assurances were provided where necessary. In short, throughout the bankruptcy process, FES stayed true to its word.

Energy Harbor appreciates the opportunity to share this good news with the Commission and other stakeholders. Going forward, Energy Harbor remains deeply committed to continue

providing excellent customer service, maintaining its market share in an extremely competitive service environment, and remaining fully compliant with all statutory and regulatory obligations.
