The Hanna – Newton Falls 138kV Transmission Line project, permit ID# UL20001-MU, has been approved by the Trumbull County Soil and Water Conservation District contingent upon the following:

- The owner, builder and contractor(s) must follow the plan, construction sequence and erosion and sediment control (ESC) details to prevent damage or degradation of waterways and/or adjacent property.
- A copy of the approved SWP3 and internal inspection reports must be available onsite.
- A pre-construction meeting must be set with this office no less than 7 days prior to soil disturbing activities.
- The SWP3 must be signed by the owner and contractor/s responsible for its implementation, prior to the start of construction.
- Subcontractor Certification must be completed prior to their start of construction.
- Ohio EPA's approval for coverage under the NPDES permit must be provided to this office.

Future site inspections may require on-site modifications or additions to erosion and sediment controls not currently shown on the approved plans.

This permit will expire three years after the issue date. If construction for this project is not anticipated to be complete at this time, the permit must be renewed before it expires. All permits renewed after the expiration date must re-submit the full fee.
