AEP Ohio representatives plan to rebuild approximately 5 miles of 138-kilovolt (kV) transmission line. The project involves replacing existing towers with steel poles between the Bethel and Sawmill substations in northwest Columbus and the Dublin area.

Company representatives filed the northern section of this project with the Ohio Power Siting Board (OPSB) in November 2019 and received approval in February. As the project continues to develop, we have filed the southern section of this project with the OPSB as the Bethel-Sawmill 138 kV Transmission Line Project (Bethel-Brookside). This section consists of rebuilding approximately 2.7 miles of power line between the existing Bethel and Brookside substations. **Please see Page 2 of this document for key regulatory information associated with this project.**


