## MEMORANDUM IN SUPPORT

Duke Energy Ohio respectfully requests that the Commission grant its motion for protective order to protect the confidentiality of information contained in the Demonstration of Status.

Duke Energy Ohio is an Ohio corporation with its principal office in Cincinnati, Ohio. Duke Energy Ohio has the corporate power and authority, among others, to engage, and it is engaged, in the business of supplying electric distribution service to customers in the State of Ohio. Accordingly, Duke Energy Ohio is a public utility within the meaning of that term as used in R. C. 4905.02 and 4905.03. As such, Duke Energy Ohio is subject to the jurisdiction of the Commission in the manner and to the extent provided by the laws of the State of Ohio.

Duke Energy Ohio owns, operates, manages and controls plants, properties and equipment used and useful in supplying electric distribution service to over 624,000 customers in southwestern Ohio.

Ohio Administrative Code Section 4901-1-24(D) allows Duke Energy Ohio to seek leave of the Commission to file information that Duke Energy Ohio considers to be confidential under seal. This rule also establishes a procedure for presenting to the Commission that information which is confidential, and therefore should be protected. Portions of the usual procedures have been temporarily waived and/or modified by the Commission in its April 8, 2020 Entry in Case No. 20-591-AU-UNC (COVID Order).

Pursuant to O.A.C. 4901:1-40-05(A), Duke Energy Ohio is required to "file by April fifteenth of each year, on such forms as may be published by the commission, an annual renewable energy portfolio status report analyzing all activities undertaken in the previous calendar year to

demonstrate how the applicable renewable energy portfolio benchmarks have been met." Among

the components of this report, the Company is required to include a "[d]emonstration of status

relative to the statutory three per cent cost provision, for the compliance year addressed in the annual

status report."3

The Commission has specifically authorized that demonstrations of status submitted under

O.A.C. 4901:1-40-05(A)(3)(d) are *not* required to be made publicly available, and are entitled to

confidential treatment. Section 4901:1-40-05(A)(3), which lists the items that must be included in

a status report, specifies that the listed content must be made publicly available "with the exception

of paragraph (A)(3)(d)," which describes the Demonstration of Status. In its Order approving the

most recent amendment to this Rule, the Commission stated that "Ohio Adm. Code 4901:1-40-

05(A)(3) has been amended to allow the electric utilities and ESCs to submit portions of the report

confidentially."<sup>4</sup>

WHEREFORE, Duke Energy Ohio respectfully requests that the Commission, pursuant to

O.A.C. 4901-1-24(D), the COVID Order, and 4901:1-40-05(A)(3), grant its Motion for Protective

Order to protect the confidentiality of information contained in the document titled ""Calculation

of Company's percent status relative to 3% cost provision in ORC 4928.64(C)(3) of Duke

**Energy Ohio, Inc.**", covering the Period January 1, 2019 through December 31," by making a

determination that the Demonstration of Status is authorized to be treated as confidential by O.A.C.

4901:1-40-05(A)(3).
