## FINDING AND ORDER

#### I. SUMMARY

 $\{\P 1\}$  The Commission revokes the certification of the Conor Davitt solar facility as an eligible Ohio renewable energy resource generating facility.

#### II. APPLICABLE LAW

- $\{\P\ 2\}$  R.C. 4928.64 and 4928.645 contain the renewable energy resource requirements for electric utility and electric services companies providing electric retail generation in Ohio. R.C. 4928.01(A)(37) defines the types of renewable energy resource generating facilities that qualify in meeting the statutory mandates.
- {¶ 3} Pursuant to Ohio Adm.Code 4901:1-40-04(D), any entity that desires to be designated an eligible renewable energy resource generating facility for the state of Ohio shall file an application for certification that demonstrates the facility satisfies the requirements of R.C. 4928.64 and 4928.645.
- {¶ 4} On June 24, 2013, Conor Davitt (Mr. Davitt) filed an application in Case No. 13-1381-EL-REN for certification of a renewable energy resource facility, the Conor Davitt solar facility (Facility) located at 2959 West Case Road, Dublin, Ohio 43017. The Facility consists of a 2.6 kilo-watt roof-mounted solar photovoltaic system.
- {¶ 5} Following approval of the application, Ohio certification number 13-SPV-OH-GATS-0510 was issued for the Facility on August 26, 2013.

{¶ 6} On December 6, 2019, Mr. Davitt filed correspondence with the Commission, advising that he is in the process of selling his house and seeks guidance on how to terminate the Facility's certificate.

- {¶ 7} On December 6, 2019, Staff filed a Review and Recommendation in which Staff recommends that the Commission revoke certificate number 13-SPV-OH-GATS-0510. According to Staff, Mr. Davitt contacted Staff on November 18, 2019, inquiring about how to cancel the Facility's license since he was in the process of selling the house that hosts the Facility. When Staff contacted Mr. Davitt to explore the possibility of transferring the certificate, Mr. Davitt expressed a preference for cancelling it. (Staff Report at 1.)
- $\{\P 8\}$  No response to Staff's Review and Recommendation has been filed by Mr. Davitt.
- {¶ 9} The Commission finds Staff's recommendation to revoke the certificate for the Facility to be reasonable. Therefore, Certificate No. 13-SPV-OH-GATS-0510 should be revoked.
