We enjoy the deer, birds and scampering wildlife.

While my husband's life on Earth ended about 4 years ago, I still enjoy the property. Our children and grandchildren also enjoy viewing the wildlife. We've had owls, wild turkeys, hummingbirds, Baltimore orioles, numerous finches and grosbeaks, we have not yet spotted an eagle's nest on our property. We love to see them elsewhere in Seneca County and hope to one day have them on our property, as well.

However, if the industrial wind turbines being proposed are built, I'm afraid that may never happen. Worse yet, I'm afraid that the ones in other areas of Seneca County will be gone, as well. This is NOT something that I want to see happen. Our home will be passed on to the next generation of our family before too long. I sincerely hope that every effort can be made to preserve this property for wildlife alongside our family.

I have numerous concerns about the wind turbines proposed. The setbacks, the safety, the lack of power produced, are just a few. But with Seneca County recently being ranked 5th in the number of bald eagle nests in State of Ohio, I feel it's important to voice my concern about the eagle's safety. I feel that it is our responsibility to speak out for the safety of our wildlife.

Please consider these issues when addressing the matter of wind turbine placement. While I would much rather not see any placed in Seneca County, I certainly think that the least we could do, is NOT place them where it would inhibit families or wildlife. Anything that you could do to help in this endeavor would be appreciated.

Dear Director Mertz,

I am writing to urge you and the Ohio Department of Natural Resources to protect the nests of Northwest Ohio's Bald Eagle population. Currently six industrial wind turbines projects are trying to locate hundred's of massive turbines throughout Erie and Seneca Counties. The proposed turbine siting in both projects falls within the Mississippi Flyway and is the corridor that thousands of migratory birds seasonally use to fly to and from the northern United States and Canada.

In particular I am concerned about the siting of turbine's in the Emerson Creek Wind Farm 18-1607-EL-BGN and the Republic Wind Farm 17-2295-EL-BGN projects. These turbine's are proposed too close to active eagle's nests. According to the Apex's own literature, turbines need to have **at least** a 2.5 mile buffer from all eagle nests. Many of the wind turbines in these two projects are being sited much to close to identified active nests.

Please help protect Erie and Seneca's Counties migratory pathways, birds and wildlife by speaking out to denying these two project's application. We thank you for your time and careful consideration in this matter.

Thank you for reaching out and sharing your concerns about the application to construct the Republic Wind Farm proposed by Republic Wind LLC, designated as case number 17-2295-EL-BGN by the Ohio Power Siting Board (OPSB) and the Emerson Creek Wind Farm proposed by Firelands Wind, LLC designated as case number 18-1607-EL-BGN. I want to assure you that my staff at the Ohio Department of Natural Resources and I are very mindful of your concerns to protect bald eagles and take them very seriously as we assess all ecological, socioeconomic, and other impacts prior to making any determinations on these cases.

As you may know, Power Siting staff at the Public Utilities Commission of Ohio (PUCO) issued reports of investigation on [Republic Wind LLC's application in July 2019](#) and [Firelands Wind, LLC's application in March 2020](#). PUCO staff consulted with various staff within the Ohio Department of Natural Resources, including those within the Division of Wildlife whose responsibility is to conserve and improve fish and wildlife resources and their habitats for sustainable use and appreciation by all. Effective science-based management of Ohio's fish and wildlife resources incorporates the complex relationships among fish and wildlife, their habitats, and the interaction of people.

The staff's investigation found bald eagle nests within the 2-mile buffer surrounding both projects. In both cases, staff recommended to the Board that Republic Wind, LLC and Firelands Wind, LLC be required to coordinate with the United States Fish and Wildlife Service (USFWS) to assure that impacts to bald eagles are minimized. If the USFWS determines that impacts to bald eagle are likely, they can require the applicants to develop and implement an [Eagle Conservation Plan](#) in accordance with federal guidance and permit regulations. In addition, prior to any turbine becoming commercially operational, Republic Wind, LLC and Firelands Wind, LLC must submit a post-construction bird and bat monitoring plan to the ODNR Division of Wildlife and for power siting staff review and approval. This monitoring plan also requires confirmation from the USFWS and should be consistent with the ODNR-approved, standardized protocol, as outlined in the ODNR's On-Shore Bird and Bat Pre-and-Post-Construction Monitoring Protocol for Commercial Wind Energy Facilities in Ohio.

Both applications are still under consideration by the full Board. I appreciate and share your passion and commitment to the safety and protection of fellow Ohioans, native species, and our landscape. My staff and I will keep your comments in mind as we continue with our thorough review of this application.

Dear Mary Mertz ;

This email is in reference to the Bald Eagle nests which are located in our state. Currently there are over 700+ nests within our state borders. Out of the eighty-eight counties in the great state of OHIO, counties along or near Lake Erie have the largest number of bald eagle nests. This is due to the abundance of food and nesting habitats. Sandusky county has 50 bald eagle nests, Erie county has 32 and Seneca County ranks 5th in the state for it's 24 eagle nest sightings. Once on the brink of extinction in Ohio, in 1979 there were only four nesting pairs found along the Lake Erie cost. We now see how the majestic eagles have come back, but for how long? Those three counties together; Sandusky, Erie and Seneca, have a total of over 106 nests. In just those three counties alone which is over 15% of the TOTAL nests sighting in all of Ohio. Seneca County is currently fighting to keep wind turbines from coming into the area. I find it frustrating, nonsensical and hypocritical that the state of Ohio especially the OPSB and the ODNR would consider allowing massive wind turbines into these three countries. The turbines that are proposed in Seneca county, of which I live are to be over 600+ in height, for a point of reference, the St. Louis Arch is 630 feet tall. Would you like having something of that magnitude outside of your home? I am against the wind turbines for MANY reasons: Karst, health, shadow flicker, decrease in property values and for the killing of birds, bats and bald eagles. Miss Mertz, as the director of OD&R I believe you to be a person of common sense and I implore you to take the time, watch the video, educate yourself and see for yourself that: "Everything that glitters is NOT gold."

Ms. Mertz,

I am writing to express my opposition to two proposed industrial wind projects (17-2295-EL-BGN, Republic Wind and 18-1607-EL-BGN, Emerson Creek Wind) currently in the pending phase of the Ohio Power Siting Board's approval process. I live in the footprint of the proposed Emerson Creek project. Although I have many unanswered concerns regarding these projects, my comments today are specific to the protection of our national symbol, the American Bald Eagle. Although no longer on the endangered species list, it is still protected by the Bald and Golden Eagle Preservation Act. In 1979, there were just four nesting pairs of eagles in Ohio. For approximately twenty years beginning in the mid 1980's, concerted efforts took place to restore the Bald Eagle population in Ohio. The Ohio Department of Natural Resources undoubtedly played a major role in those efforts using our tax dollars to do so. Those efforts paid off as there are now just over 700 nesting pairs in Ohio, and growing. 121 of those nests or over 17% are in just a four county area (Erie, Sandusky, Seneca and Huron) which are the proposed sites for the two projects mentioned above. Include Ottawa County which borders Sandusky and Erie counties and this five county area in North Central Ohio is home to nearly 30% of the nesting pairs in Ohio. Nesting pairs average 1.5 offspring per year so there will be approximately 740 new and existing eagles combing the skies in this five county area. Obviously the eagles aren't aware of county lines drawn on a map so it stands to reason that the approximately 300 offspring will be spreading out looking for food and suitable nesting sites.

Some additional questions/concerns:

- How many eagles are the wind developers allowed to "take" with their permits - "take" is defined as harassing, harming, pursuing, hunting, shooting, wounding, killing, trapping, capturing or collecting or attempting to engage in such conduct." What if they exceed their allowable "take"?
- How much does such a permit cost the developer? I have heard it is tens of thousands of dollars. Since the wind companies are heavily subsidized, I can only assume that some of our tax dollars would now be used to purchase such a permit that would allow the "taking" of the eagles that other tax dollars originally were used to restore the population.
- Who monitors and reports the "take"? The wind developer? Unlike the staff of the OPSB, there is not a lot of community trust in these companies to self-monitor.

Does it really make sense to build 650 foot towers with blades rotating at nearly 200 mph in the area of the state where the protected eagle population is thriving? I think not.

I would like to state my opposition to the proposed Industrial Wind Turbine projects, both Republic Wind #17-2295-EL-BGN and Emerson Creek #18-1607-EL-BGN. I am asking that before any approvals are given to Apex or any other wind company, that your organization reviews all of the information available regarding the hazards of turbines.

These turbine companies have promised great financial benefits, but I believe this is only to mask their actual detriment to life!

Seneca Co has ranked 5th in the state for their eagle population. These nesting birds should have at least 2.5 miles of hazard-free flight area for hunting and free flight. Obviously, erecting 600'+ turbines is detrimental to their safety. Unfortunately, Bowling Green witnessed what these massive machines will do to these birds! One can't help but wonder how many other birds and bats have been slaughtered by turbines? What happens to the area insect population, when the bat population is dramatically decreased by the turbines? How many humans will be impacted by the insect-borne diseases? West Nile?
