{¶ 1} Ohio Power Company, Duke Energy of Ohio, Inc., The Dayton Power and Light Company, Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively, electric utilities) are public utilities as defined in R.C. 4905.02, and, as such, are subject to the energy efficiency and peak demand reduction (EE/PDR) requirements of R.C. 4928.66 through 4928.662. Compliance with the EE/PDR requirements is achieved through implementation of EE/PDR portfolio plans that have been proposed by each electric utility and approved by the Commission.

{¶ 2} R.C. 4928.66(B) requires the Commission to produce and docket an annual report containing the results of its verification EE/PDR requirements achieved by each of the electric utilities and to provide a copy of the report to the Ohio Consumers' Counsel.

{¶ 3} On November 29, 2019, Staff filed, on behalf of the statewide Independent Program Evaluator (Evaluator), a report containing the results of the Evaluator's verification of the annual levels of energy efficiency and of peak demand reductions achieved by each of the electric utilities from 2014 through 2018.

{¶ 4} In order to assist the Commission in its review of the Evaluator's report, a comment period should be established. Interested persons are invited to file written comments with the Commission's docketing division within 30 days of this Entry.

{¶ 5} It is, therefore,

{¶ 6} ORDERED, That interested persons file comments on the Evaluator's report in accordance with Paragraph 4. It is, further,

{¶ 7} ORDERED, That a copy of this Entry be served upon Ohio Power Company, Duke Energy of Ohio, Inc., The Dayton Power and Light Company, Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company, and all other parties of record.
