Verizon Communications is providing notice of an internal reorganization pursuant to which Alltel Communications LLC ("Alltel Com") was merged into its parent corporation, Alltel Corporation ("Alltel Corp."). Both Alltel Communications LLC and Alltel Corporation were wholly-owned and controlled by Verizon Communications and the transaction was part of an internal corporate reorganization that reduced costs and provided enhanced operational and economic efficiencies for the surviving Verizon entities. Effective December 31, 2018, the name Alltel Communications LLC is changed to Alltel Corporation.

In addition, please find attached the Ohio Secretary of State documents showing the merger and the fictitious name filing.




