Supplement to Notice of Compliance with Service Requirement for **Third Public Information Meeting**

Dear Ms. Troupe:

Pursuant to Rule 4906-3-03(B)(2) of the Ohio Administrative Code, on June 11, 2020, Madison Fields Solar Project, LLC ("Applicant") filed notice that it has complied with the service requirement set forth in this rule. In accordance with this rule, a letter was sent by first class mail at least 21 days before the meeting to the property owners and tenants affected by this facility notifying them of the third public information meeting that was held on June 16, 2020. In addition, this notice was sent to county and township public officials, and the local school district. Exactly 130 mailers were sent. These notices also included information about the project and an insert on how to access the presentation of the project and how to participate in the June 16, 2020 meeting. The letter and the inserts that accompanied the letter are attached hereto.

Both the letter and the insert provided information and the telephone number that the public could use to access the meeting. It came to the Applicant's attention just prior to the meeting on June 16th that, while the letter and newspaper notice contained the correct telephone number, the insert and social media information transposed the number and consequently the caller was routed to another recipient. However, two hours prior to commencement of the meeting, the social media telephone number was corrected, so that it accurately reflected the call-in telephone number. In addition, the Applicant coordinated with the other recipient and arranged for the recipient to provide any caller with the correct call-in number for the meeting. From review of the process and information from those that attended the meeting, coordination with the recipient worked and callers were successfully provided the correct call-in number.

The Applicant is committed to working with the community and wants to provide information and answer any questions that the public may have regarding the project. To that end, the Applicant will be posting a recording of the live phone-in session on both the FaceBook page and the mircrosite, as well as continue to accept questions submitted through the website throughout the permitting process and have subject matter experts contact the community member directly for conversation or discussion upon the issues of their concern, and will provide another opportunity for the public to directly interact with the Applicant. Specifically, the Applicant will be providing email and telephone number access for the project manager so that individuals can contact her directly to obtain more information on the project and ask any questions they have. Notice of this opportunity and the project manager's contact information will be mailed via letters to the same 130 individuals that received notice of the June 16, 2020 meeting. In addition, the Applicant will publish notice of this opportunity in the newspaper.

Notice of **Public Information Meeting for Proposed Major Utility Facility**

Madison Fields Solar Project, LLC, a wholly-owned subsidiary of Savion, LLC, held two public informational meetings in Madison County, Ohio, on November 5 and 6, 2019, to outline plans to build the Madison Fields Solar Project, a solar-powered generation facility located in Madison County. The facility will be sited on approximately 1,000 acres and have a maximum total generating capacity of up to 180 megawatts. The purpose of the facility is to generate electricity and is intended to fill the need for a more diverse national energy portfolio that will include a higher percentage of energy generated through the use of renewable resources. The facility design has been optimized to utilize land and still provide environmental and visual setbacks to achieve a minimal impact to natural resources and adjacent residents' viewshed. Construction is anticipated to begin as early as first quarter of 2022, resulting in commercial operations in fourth quarter 2022.

On Tuesday, June 16, 2020, from 6:00 p.m. to 7:00 p.m., Madison Fields will host an additional public information meeting that will be virtual and will consist of a live phone question and answer (Q&A) session on the project. The meeting will be virtual in nature to adhere to the current restrictions regarding public gatherings. The public will be able to participate in the Q&A session by telephone. Similar to the meetings held in November, questions will be answered directly by the subject matter experts. The live phone Q&A session will be brought to you via telephone, there will be no visual presentation during the event.

During the live phone Q&A, instructions will be provided to submit questions. For additional information on how to access the live phone Q&A contact the Madison Fields team via the addresses or telephone number listed above.

Madison Fields anticipates filing its application with the Ohio Power Siting Board (OPSB) within 90 days of the live phone Q&A session. OPSB's case number for the project is 19-1881-EL-BGN and the filings made with the OPSB in the Madison Fields case can be viewed at http://dis.puc.state.oh.us/CaseRecord.aspx?Caseno=19-1881&link=DI.

Upon the receipt of the application, OPSB will review the application to determine if it is complete so OPSB staff can begin its investigation. Should OPSB find the application complete, OPSB will set a date for public hearing, not less than 60 nor more than 90 days after such finding. The public hearing consists of two parts: a public hearing where OPSB will accept written or oral testimony and an adjudicatory hearing. 15 days prior to the public hearing, OPSB's staff will submit a written report on the project.

OPSB accepts written comments on the project from interested persons at any time, as well as written or oral testimony from any person at the public hearing. Petitions to intervene in the adjudicatory hearing will be accepted by OPSB in accordance with a deadline set by OPSB.
