Pursuant to Rule 4906-3-03(A) of the Ohio Administrative Code, Madison Fields Solar Project, LLC (“Applicant”) files this Third Preapplication Notification Letter with the Ohio Power Siting Board (“Board”) regarding its proposed solar-powered electric generation facility.

The proposed facility, the Madison Fields Solar Project, is a solar-powered electric generation facility located in Madison County, Ohio. The solar facility is expected to have a maximum total generating capacity of 180 megawatts. The Applicant will provide clean renewable energy to electricity consumers.

The Applicant anticipates filing its application with the Board within the next 90 days. Construction is estimated to begin as early as the end of 2021 or first quarter 2022, resulting in commercial operations in 2022.

The Applicant has scheduled a fourth public informational meeting scheduled for Tuesday, July 15, 2020, from 6:00 p.m. to 7:00 p.m. to outline plans to build the Madison Fields Solar Project. This meeting will be virtual and will consist of a live phone question and answer (Q&A) session on the project. A presentation about the Madison Fields Project is posted on Madison Field’s website (www.madisonfieldssolarproject.com) and Facebook page (www.facebook.com/MadisonFieldsSolarProject) for viewing by the public at their convenience.
