NOTICE OF REVISION TO PROJECT FOOTPRINT

Hecate Energy Highland LLC ("Hecate Energy") provides notice of its revision to the project footprint of its Highland Solar Farm, a 300 MW solar powered electric generating facility to be located in Highland County, Ohio. Hecate Energy was issued a certificate of environmental compatibility and public need ("Certificate") by the Ohio Power Siting Board ("OPSB") on May 16, 2019. Consistent with (3) of **IV. STIPULATION AND CONDITIONS** of the Certificate, Hecate Energy will be providing its final design to OPSB Staff at least thirty (30) days before the pre-construction conference required by (2) of those stipulations and conditions. In the interim, Hecate Energy provides this notice of revision to the project footprint. The revision removes approximately 602.996 acres of wooded and agricultural land from the previously submitted project footprint at Figure 2 of the application for the Certificate. The parcels that have been removed are the following:




The parcels removed are all situated in the eastern/northeastern portion of the project site. The removal will result in a reduction of the project site from approximately 3,400 to 2,800 acres. The reduction results from the optimization of the panel design for the facility. A map that outlines the revised project footprint is attached as Exhibit A. Notably, the removal of land will reduce the number of off-site residences in the viewshed of the project. The revised project footprint will allow compliance with all requirements of **IV**. **STIPULATION AND CONDITIONS** and the Certificate issued for the project.
