**OHIO POWER COMPANY’S NOTICE OF FILING OF TWO-MONTH UPDATE**

---

Ohio Power Company (“AEP Ohio” or the “Company”) is a public utility as defined by Ohio Revised Code (R.C.) 4905.02 and 4905.03 and is engaged in the business of supplying electric transmission and distribution service to approximately 1.5 million customers in Ohio. The Company’s Application in this case was filed pursuant to R.C. 4909.18 and related sections of the Ohio Revised Code for authority to make changes and increases in electric distribution rates applicable in all incorporated communities and unincorporated areas within AEP Ohio’s entire service territory. Pursuant to the Commission’s Standard Filing Requirements, AEP Ohio is filing its two-month update today in a separate volume.

The updated schedules in the two-month update (Schedules A-C, E-4 and E-4.1) replace the corresponding schedules filed with the Company’s June 1, 2020 Application to increase rates for distribution service. As indicated on Line 8 of the updated Schedule A-1, the Company’s updated filing shows a revenue deficiency prior to recognition of the changes in riders of \$401,265 thousand compared to the original filing which shows \$402,086 thousand. As

indicated on Line 9 of the updated Schedule A-1, based upon the updated billing data, the rates as filed in the Pre-Filing Notice would produce an increase of \$392,461 thousand. Once the changes in riders are recognized, the updated Schedule A-1 on Line 13 would produce a net increase of \$35,538 thousand under the Pre-Filing Notice rates.
