MOTION FOR EXTENSION OF CERTIFICATE

Pursuant to Rule 4901:1-24-04 of the Ohio Administrative Code, Lighthouse Power Partners, LLC (“Lighthouse”) seeks an extension of Certificate No. 16-1609E, which was issued in Case No. 16-0661-EL-AGG. The expiration date of Certificate No. 16-1609E was May 26, 2020. Due to disruptions caused by the COVID-19 pandemic, Lighthouse did not file its renewal application before the expiration of its Ohio electric certificate. In conjunction with this motion, Lighthouse is preparing its renewal application through the PUCO Community and will be filing it soon. Lighthouse respectfully requests that Certificate No. 16-1609E be extended from May 26, 2020, until the date that the renewal certificate is issued.

WHEREFORE, Lighthouse respectfully requests that Certificate No. 16-1609E be extended from May 26, 2020, until the date that the renewal certificate is issued, and Lighthouse be authorized to continue to operate during the pendency of the renewal application certification review.

**MEMORANDUM IN SUPPORT OF
MOTION FOR EXTENSION OF CERTIFICATE**

Lighthouse Power Partners, LLC did not meet the date for its renewal application in Case No. 16-0661-EL-AGG and its Ohio electric certificate has expired because business was interrupted as a result of the COVID-19 pandemic. Lighthouse apologizes for this delay. Lighthouse is preparing its renewal application and utilizing the Commission's on-line process for its preparation and submittal for filing.

Rule 4901:1-24-04 of the Ohio Administrative Code provides that a supplier may request an extension of a prior certificate and such a motion requesting an extension of a previous certificate will be deemed automatically approved (unless ruled otherwise by the Commission or an Attorney Examiner within three business days), if a renewal application is filed no later than 60 calendar days after the expiration date of the certificate. Lighthouse submits that it will meet this criteria. Additionally, Lighthouse requests that the certificate be extended in accordance with the Commission's June 3, 2020 decision¹ to allow an extension of a previous certificate for up to 90 days while the renewal application is reviewed.

Lighthouse requests an extension of Certificate No. 16-1609E issued in Case No. 16-0661-EL-AGG from May 26, 2020, until such time as a renewal certificate is issued.
