In accordance with the Commission's February 26, 2020 Opinion and Order in the above-captioned proceeding, The East Ohio Gas Company d/b/a Dominion Energy Ohio (DEO) hereby formally withdraws Fifth Revised Sheet No. B-MVR 1 and Fifth Revised Sheet No. B-MVR 2, which concerned DEO's Monthly Variable Rate Commodity Service. As provided for in Paragraph 4 of the February 5, 2020 Stipulation and Recommendation (Stipulation) approved by the Commission, the Monthly Variable Rate Commodity Service tariff has been replaced with the Monthly Retail Rate Commodity Service tariff, which DEO submitted on July 10, 2020.

Please find attached an updated Table of Contents for DEO's tariff that reflects the withdrawal of the Monthly Variable Rate Commodity Service tariff. Please update accordingly the Commission's copy of DEO's tariffs.
