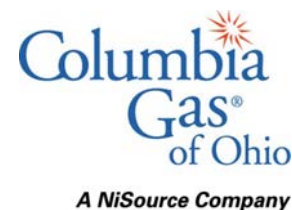

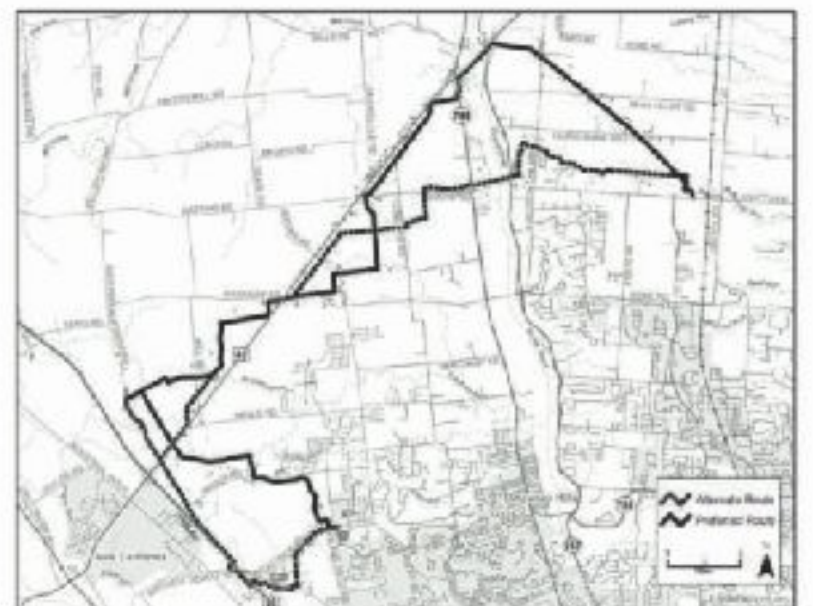
Columbia Gas of Ohio, Inc. ("Columbia") is hosting a virtual public information meeting on Monday, August 17, 2020, from 6:00 to 8:00 p.m. to discuss Columbia's proposed facility referred to as the Northern Columbus Loop Project – Phase VII (the "Project"). To access the meeting, go to [nsource.webex.com](http://nsource.webex.com) or call 1-866-692-3580. The meeting number is 129-732-1312, and the Password is InTheLoop2020.

The Project, located in Delaware and Union Counties, will install approximately 12 miles of 24-inch coated steel main and 4 miles of 16-inch coated steel main along either the Preferred Route or the Alternate Route. The general location of the proposed Project is shown in the accompanying map in this notice.

The Project is needed in order to increase the operational flexibility of Columbia's natural gas delivery system and to serve growth occurring in the Greater Columbus Region. The Project ties into the existing Northern Columbus Loop system at Hyatts Road, and continues northwest until it meets U.S. Route 42. From there, it travels southwest along U.S. Route 42 to Watkins California Road, turning southeast at that point and ending with a connection to Columbia's North Columbus High Pressure system east of Hyland-Croy Road along McKittrick Road. Columbia anticipates beginning construction in February 2022 and ending construction in December 2022.

To construct, operate, and maintain the Project, Columbia must submit an application with the Ohio Power Siting Board to obtain a Certificate of Environmental Compatibility and Public Need. Though the application has not been filed, Columbia has opened the case for its review, Case No. 20-1236-GA-BTX. Once filed, the Ohio Power Siting Board will review the application, and, if certain legal criteria are met, may approve the Project.
