In addition, in light of the fact that the hearing currently is scheduled to start on September 29, 2020, and testimony is currently due September 22, 2020, Duke Energy Ohio requests an expedited ruling.

MEMORANDUM IN SUPPORT

Duke Energy Ohio, Inc. (Duke Energy Ohio), initiated this case by the filing of an application for a new alternative rate plan to establish a capital expenditure program rider (Rider CEP) to recover the post-in-service carrying costs, incremental depreciation expense, and property tax expense currently deferred pursuant to Duke Energy Ohio's CEP Deferral, as well as a return on and of the underlying assets to which these expenses are directly attributable in the capital expenditure program. Staff of the Public Utilities Commission of Ohio (Commission) issued a Staff Report and Recommendation on June 17, 2019, recommending a thorough audit of plant, comprising not only all CEP investments from January 1, 2013, through December 31, 2018, but also all plant investments from the date certain in last rate case (March 31, 2012) through the commencement of the CEP program. An Entry filed by the Commission on September 26, 2019, directed Staff to issue an RFP directing an audit report to be filed no later than March 11, 2020. Subsequently, on January 28, 2020, Duke Energy Ohio filed a motion for an extension of that procedural schedule and a 60-day extension was granted on February 13, 2020, which directed the audit report to be filed by May 11, 2020. On May 27, 2020, an Entry setting a procedural schedule was filed scheduling a hearing date for September 1, 2020, and setting expedited discovery and motion response dates.

The parties have been working toward resolution of the issues. Duke Energy Ohio now requests that the hearing date be postponed until October 27, 2020, or thereafter, to allow additional discussion between the parties and so that settlement terms can be further considered.

Based on the telephone and email communications among counsel, it is Duke Energy Ohio's understanding that no party objects to either the substance of this motion or the expedited treatment thereof.
