I have noticed that Apex Clean Energy has begun, again, to flood the OPSB Public Comment section with **form letters** "in support of" the Emerson Creek Wind Project (19-1607-EL-BGN)

I have attached a copy of these form letters, along with snippets of the ones that were posted on the OPSB website on September 21-22, 2020, and a map of Ohio that shows where these "supporters" actually live. (This is certainly not what I want to waste my time doing, but feel it's important the truth be known, and seen).


