Dear Valued Customer,

DP&L values you as a customer and makes every effort to keep you informed of changes that may affect your property. We are writing to share the improvements The Dayton Power and Light Company ("DP&L") is making to an electric transmission substation that is close to your property. The work is being done at the Bath Substation which is located in Xenia, Greene County.

As described in the Construction Notice Application, which was approved by the Ohio Power Siting Board ("OPSB") on December 10, 2019 (Case Number 19-1345-EL-BNR), the improvements will consist of adding a second 345/1389kV transformer. This project is being undertaken to comply with mandatory North American Electric Reliability Corporation (NERC) reliability requirements. The improvements will strengthen the electric system and will improve reliability by relieving thermal loading issues under certain contingencies.

The entire construction of the substation expansion will be on existing DP&L property. Therefore, your property will not be disturbed.

Actual construction for the project is scheduled to begin in mid October 2020 and the new equipment is expected to be in-service by June 2021. Customers should not see any interruption to their electric service because of this work. We understand the construction project will present a temporary inconvenience as we work to strengthen our infrastructure to provide safe, reliable electric service.

Please note, DP&L employees always carry company identification. Contracted personnel also carry company identification along with documentation that they are working for DP&L. If you have any questions about whether someone works for DP&L please call 800-433-8500 to verify.


