MEMORANDUM IN SUPPORT

On August 4, 2020, Palmco moved the Commission for a temporary stay of these proceedings, including a stay of discovery, pending the Supreme Court of Ohio's resolution of Palmco's complaint in prohibition, docketed as Case No. 2020-0564. The Commission had previously moved to dismiss that complaint, asserting that it failed to state a cause of action. On August 19, 2020, the Supreme Court of Ohio granted the Commission's motion and dismissed Palmco's complaint. That same day, Staff notified the Commission of the Court's ruling in Staff's memorandum contra Palmco's motion to stay.

Because Palmco's August 4, 2020 Motion to Stay Proceedings Pending the Ohio Supreme Court's Resolution of the Complaint in Prohibition is now moot, Palmco moves the Commission to establish a procedural schedule for this proceeding. Palmco respectfully proposes the following schedule:

November 9, 2020: Deadline for serving discovery requests, including deposition notices

November 16, 2020: Staff Report due

November 23, 2020: Testimony due

December 7, 2020: Hearing
