## **ENTRY**

- {¶ 1} By Entry issued in the above-captioned case on September 14, 2020, a settlement teleconference was scheduled to occur on October 30, 2020. The stated purpose of the settlement teleconference was to facilitate, including through the auspices of a Commission-supplied mediator, a possible resolution of this matter between the parties themselves.
- {¶ 2} On October 27, 2020, Complainants corresponded with the attorney examiner, informing him that settlement negotiations between the parties are already underway and, likely, are near completion, contingent upon an exchange of documents between the parties that is expected to soon happen. On that basis, Complainants have asked that the scheduled October 30, 2020 settlement teleconference be canceled or, at least, indefinitely postponed, pending the outcome of the settlement efforts currently underway between the parties.
- {¶ 3} The attorney examiner finds that this request is for good cause and should be granted. Accordingly, the settlement teleconference which had been scheduled for October 30, 2020 is canceled. In the event that, in the near future, a formal document is filed in this docket asking for the case to be dismissed as a settled matter, the attorney examiner will be in position to recommend to the Commission that this matter be dismissed and closed of record. In the event that no such filing occurs, the attorney will work with the parties to

ascertain the need for issuing, instead, a separate, future entry scheduling a settlement teleconference to take place in lieu of the one being canceled by today's Entry.
