This is in response to your correspondence and attached report, received on November 20, 2020, regarding the addendum work associated with the Duke Energy Ohio, Inc. Central Corridor Pipeline project in Hamilton County, Ohio. The comments of the State Historic Preservation Office (SHPO) are made in accordance with the provisions of Section 106 of the National Historic Preservation Act of 1966, as amended, and the associated regulations at 36 CFR Part 800.

An additional 8.8 acres of ROW and workspaces was surveyed for this undertaking. No additional historic resources were identified. Therefore, there is no change to the original determination as set forth in the letter from SHPO dated September 14, 2020. This undertaking will not adversely affect historic properties if the cemetery monitoring plan is fulfilled when appropriate.
