The purpose of this letter is to notify you that the Staff Report filed by the Staff of the Public Utilities Commission of Ohio on November 18, 2020, and sent to you by certified mail on November 19, 2020, in accordance with R.C. 4909.19, was amended in order to correct a clerical error contained within the schedules of the Staff Report for which three values were erroneously deleted.
