A RESOLUTION AUTHORIZING THE WILLIAMS COUNTY COMMISSIONERS TO ACT AS THE PURCHASING AGENT AND GOVERNMENTAL AGGREGATOR FOR ELECTRIC POWER FOR THE VILLAGE OF EDON.

Whereas, on November 8, 2011, the residents of the Village of Edon voted in favor of electric aggregation to improve purchasing leverage and offer reduced electrical generation rates to residential and small business consumers, and,

Whereas, the Williams County Commissioners have affered their services to act on behalf of all Villages in Williams County as the governmental aggregator, and,

Whereas, having one centralized aggregator will provide for the most expeditious manner to handle any issues arising in the process of electrical aggregation.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Edon, Williams County, Ohio, at least two-thirds of all members elected thereto concurring, as follows:

Section 1. Council hereby authorizes the Williams County Commissioners to act as the governmental agent for purchasing and aggregation of electric power for the residents of the Village of Edon.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were so adopted in an open meeting of this Council, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements.

Section 4. This Resolution shall be effective at the earliest time permitted by law.
