Dear Ms. McNeal:

After the December 14, 2020 filing of the *Joint Interlocutory Appeal, Request for Certification to the Full Commission, and Application for Review* in the above-referenced case, the Environmental Law & Policy Center ("ELPC") received notice from Steven T. Nourse, Ohio Power Company's counsel of record, that he had not received ELPC's discovery request sent on December 9, 2020. A review of the email propounding that request showed that Mr. Nourse's email address was improperly spelled. Upon notification of the email error on December 14, 2020, ELPC immediately sent Mr. Nourse the request. The December 9th discovery was served on Christen M. Blend and the Ohio Power Company's outside counsel.

Because of this inadvertent error, page two of the *Joint Interlocutory Appeal* should note that ELPC served discovery on Ohio Power Company's attorneys except Steven T. Nourse due to an error with his email address and that Mr. Nourse received the discovery on December 14, 2020. Page four of the Memorandum in Support should similarly note that ELPC served discovery on December 9, 2020 to Ohio Power's attorneys except Steven T. Nourse, who successfully received discovery on December 14, 2020.
