NOTICE OF WITHDRAWAL OF APPLICATION

Now comes Duke Energy Ohio, Inc., (Duke Energy Ohio) and hereby respectfully withdraws its Application filed on July 31, 2020 in the above styled proceeding.¹ As part of a Stipulation and Recommendation filed in Case No. 19-664-GA-RDR on December 9, 2020, Duke Energy Ohio agreed to the settlement term of filing a notice of withdrawal in the instant case, its current Rider AU application case, if no Application for Rehearing was filed within 45 days of the Finding and Order issued in Case No. 19-664-GA-RDR.² Pursuant to the Finding and Order filed on February 10, 2021 in Case No. 19-664-GA-RDR approving the terms of the Stipulation and Recommendation,³ Duke Energy Ohio is submitting its Notice of Withdrawal in compliance and requests that this matter be closed immediately.
