1. In Mercury's prior ETC designation, for the CAF Phase II funding, Mercury did not ask for protective treatment for the pricing schedule. How is the pricing schedule included in the Motion for Protective Treatment filed in this filing different from the pricing information included in the prior case?

The pricing schedule for CAF Phase II funding was based on existing services and pricing that were well known within our existing service territory. For RDOF Phase I support, Gigabit service pricing is not yet known by consumers or competitors as we have not yet completed any residential fiber-optic deployments. Mercury respectfully requests that this pricing information be withheld until, at a minimum, we begin advertising and installing residential fiber service. Mercury believes it would put the Company at a competitive disadvantage to advertise our intended package and pricing structure well in advance of network construction, since this is not information a public or private party could obtain through our web site or call center.
