Please take notice that the Citizens' Utility Board of Ohio ("CUB Ohio") hereby withdraws from the above-captioned cases. CUB Ohio should no longer be considered a party to these proceedings and may be removed from parties' service lists.

CUB Ohio appreciates that the Joint Stipulation and Recommendation filed in this case on March 12, 2021 preserves the ability of Ohio Power Company to advance proposals related to the demand-side management programs in future proceedings. CUB Ohio supports the establishment of such programs to provide benefits to residential and small business customers, and looks forward to participating the workshops announced by the Public Utilities Commission of Ohio in Case Nos. 16-743-EL-POR *et al.* to address the nature and scope of energy efficiency and demand-side management programs going forward in Ohio.
