Dear Chair French and Commissioners,

This letter is submitted to notify the Commission of the emergence from Chapter 11 of Frontier North Inc.; Frontier Communications of Michigan, Inc.; and Frontier Communications Online and Long Distance Inc. (collectively, the "Frontier Ohio Regulated Companies") and the completion of their reorganization process pursuant to the United States Bankruptcy Code.

As previously advised in the Application to Transfer Control, the Frontier Ohio Regulated Companies, their parent entity Frontier Communications Corporation, and its affiliates (collectively, the "Frontier Filing Entities"), filed petitions under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court") on April 14, 2020. The filing of these petitions and associated Bankruptcy Court relief converted the legal status of the Frontier Filing Entities to debtors-in-possession that have continued to operate the business during the Bankruptcy Court-supervised reorganization process.

The Frontier Ohio Regulated Companies emerged from bankruptcy on April 30, 2021 pursuant to and in accordance with the plan of reorganization (the "Plan," and the transactions contemplated thereunder, the "Restructuring") approved by the Bankruptcy Court on August 27, 2020. Prior to emergence from Chapter 11, the Frontier Ohio Regulated Companies operated as wholly owned subsidiaries of Frontier Communications Corporation, a publicly traded corporation. As part of the Restructuring, Frontier Communications Corporation will be dissolved and a new

parent company, Frontier Communications Parent, Inc. ("Reorganized Frontier"), was established and will be publicly listed as soon as practicable on a U.S. exchange.

The Frontier Ohio Regulated Companies will operate as wholly owned indirect subsidiaries of Reorganized Frontier and intend to continue their existing operations and to comply with all existing regulatory obligations and commitments without any change as a result of the Restructuring.
