MEMORANDUM IN SUPPORT

This matter is a petition for closure of railroad grade crossings at Franklin Street in Orange Township, Delaware County, Ohio. The Board has fully cooperated in discovery, both formal and informal, in this matter and worked in good faith to support a resolution to this matter as negotiated between the Orange Township Board of Trustees, the petitioners, and the Ohio Rail Development Commission. It was on this basis that the Board supported the previous continuance of the evidentiary hearing in this matter, which was granted by Entry dated February 25, 2021. Subsequent to that entry, the "agreement in principle" referenced in the Entry was formalized in writing by the Ohio Rail Development Commission and by a resolution adopted by the Orange Township Board of Trustees on April 19, 2021. Due to the pending voluntary closure of the grade crossings in question, the Board did not prepare written testimony to submit by the deadline stated in the Entry (May 25, 2021) or prepare evidence for presentation at the hearing scheduled for June 1, 2021. Undersigned counsel for the Board was notified yesterday that the Orange Township Board of Trustees took formal action last Friday, May 21, 2021, to rescind its action approving the voluntary closure.

Prior to the negotiated voluntary closure, and due to the Board having well-founded objections and concerns with the proposed closures, the Board had planned to contest the merits of the petition at the evidentiary hearing. This included submitting pre-filed testimony in advance of the hearing. However, as stated above, that testimony was not prepared due to the negotiated voluntary closure, and the lateness of the notice of Orange Township's action will now require additional time to prepare and file the testimony. The short timeframe has made it impractical and unduly burdensome for the Board to adequately prepare the testimony and prepare for the evidentiary hearing. In addition, the Board was not able to submit its Motion further in advance because it was not aware of the Orange Township action until after its regularly-scheduled meeting yesterday morning.

Accordingly, for good cause shown, the Board respectfully requests that the Board convert the June 1, 2021 hearing scheduled for next week to a prehearing conference to discuss a new procedural schedule, including an extended deadline for the submission of written testimony. Given that written testimony is due today (May 25, 2021), the Board requests an expedited ruling on this Motion, as authorized by Ohio Adm. Code 4901-1-12(C). Due to the urgent nature of this filing, the Board cannot certify that no party has opposed the Motion or the request for an expedited ruling.
