# Vectren Energy Delivery of Ohio, Inc. Case No. 21-0320-GA-UEX

#### **OVERVIEW**

In Case No. 03-1127-GA-UNC, the Public Utilities Commission of Ohio (Commission) authorized the concept of an uncollectible accounts expense recovery mechanism for five natural gas companies. The mechanism approved allows for recovery of actual bad/uncollectible debt through a rider, rather than through base rates. Subsequently, in Case No. 03-2571-GA-ATA, the Commission authorized Vectren Energy Delivery of Ohio, Inc., d/b/a/ CenterPoint Energy Ohio (VEDO or Company) to establish an uncollectible expense rider recovery mechanism, initially set at \$0.00382 per Mcf.

Since that time, VEDO has filed annual updates to adjust its rider rate and the Commission has authorized such revisions. The most recent history of VEDO's uncollectible expense rider rate is as follows:

August 2016 - July 2017	\$0.0470 per Mcf
August 2017 - August 2018	\$0.0397 per Mcf
September 2018 - August 2019	\$0.0569 per Mcf
September 2019 – June 2020	\$0.0703 per Mcf
July 2020 – Current	\$0.0785 per Mcf

In its application, filed on May 28, 2021, VEDO proposes to modify its existing uncollectible expense rider rate of \$0.0785 per Mcf to \$0.0276 per Mcf, a decrease of \$0.0509 per Mcf. Staff has reviewed VEDO's application and makes its findings and recommendations herein.

### **STAFF REVIEW**

Staff's review of VEDO's Application included examination of its Uncollectible Expense Rider Annual Balance Reconciliation (Attachment 1), its Uncollectible Expense Rider Calculation (Attachment 2), its Write-Off and Collection Summary (Attachment 3), and its Red-Lined and Proposed Tariff Sheets (Attachment 4). Staff notes that a prudence review of this rate, if approved, will occur in a future uncollectible expense audit proceeding.

#### STAFF RECOMMENDATION

Staff completed its review of VEDO's UEX from January 1, 2020 through April 30, 2021 and finds that the Company appropriately calculated the rider rate in the pending application and recommends that the proposed rate of \$0.0276 per Mcf be approved.
