Pursuant to PUCO Staff advice, we are submitting a revised Exhibit B that includes an **amended Page 57** to correct an error in our June 17, 2021 filing.

Per the information in our previous submission, this filing is submitted in compliance with the **Federal Communication Commission's October 9, 2020, 8YY Access Reform WC Docket No. 18-156 Report and Order** that requires carriers to establish their 8YY originating rates for intrastate access minutes of use equal to the 8YY originating rates for interstate access minutes of use as provided in Cox Communications Tariff FCC No. 4. The Order further requires carriers to make reductions to their 800 data base query rates.

We respectfully request that this new Exhibit B, submitted today, replace our Exhibit B previously filed on June 17.
