On July 7, 2021, the Ohio Power Siting Board, through its administrative law judge (“ALJ”), issued an entry that ordered parties to file their lists of issues for cross-examination by September 10, 2021. In the July 7, 2021 entry, the ALJ instructed the parties to list the “specific concerns about which they may be interested in pursuing cross-examination of witnesses at the evidentiary hearing.” Juliet Energy Project, LLC (“Juliet”) hereby submits its cross-examination issues list:

1. Staff’s investigation, findings, and recommendation regarding Conditions;
2. Juliet may pursue cross-examination of any party called as a witness to the case regarding matters relevant to this proceeding;
3. Juliet may pursue cross-examination from any individual subpoenaed to attend this proceeding; and
4. Juliet reserves the right to amend or supplement this issues list. Further, Juliet’s failure to include an issue on this list does constitute a waiver of Juliet’s right to cross-examine witnesses on additional issues at the hearing.
