## JOINT NOTICE OF SWITCHYARD TRANSFER

The Ohio Power Siting Board's September 22, 2016 Opinion, Order, and Certificate (the "Certificate") approving South Field Energy, LLC's ("SFE") Certificate of Environmental Compatibility and Public Need for the construction, operation, and maintenance of its transmission line and switchyard incorporated the Partial Joint Stipulation and Recommendation filed on June 28, 2016, which established commitments and conditions that are to be followed. Condition No. 27 provides that:

SFE will construct and transfer ownership of the switchyard to [American Transmission Systems, Incorporated ("ATSI")] in accordance with applicable [PJM Interconnection, LLC ("PJM")] requirements, as well as associated agreements between SFE, ATSI, and PJM. Upon completion of the switchyard, and after ATSI's acceptance, SFE and ATSI shall file a joint notice with the Board, in which ATSI will accept and agree to comply with all conditions in the Board's certificate.

In compliance with Condition No. 27, SFE and ATSI hereby certify that SFE has constructed and transferred ownership of the switchyard to ATSI in accordance with applicable PJM requirements, as well as associated agreements between SFE, ATSI, and PJM. The switchyard portion of the Certificate is thus deemed transferred to ATSI and ATSI hereby accepts

and agrees to comply with all terms, conditions, and modifications (as may occur from time to time) of the Certificate applicable to the transferred switchyard.
