MEMORANDUM IN SUPPORT OF MOTION FOR EXTENSION OF TIME AND REQUEST FOR EXPEDITED RULING

Pursuant to Ohio Adm.Code 4901-1-12, the Retail Energy Supply Association ("RESA") respectfully requests that the procedural schedule set by the Attorney Examiner's October 15, 2021 Entry be revised slightly. Lead counsel for RESA is unavailable the week of November 22, 2021, due to a long-established family commitment and is scheduled to fly out of state the afternoon of November 22, 2021. These arrangements were booked and paid for months prior to the procedural entry issuing on October 15. Given this conflict, RESA requests that the current evidentiary hearing date be moved forward to commence on November 18, 2021 or in the alternative November 19, 2021.

There is good cause for moving the hearing. As noted above, lead counsel for RESA is scheduled to fly out of state on November 22nd and not return until Saturday, November 27th. The requested shift in the hearing date to the prior week would not delay the hearing.
