- Setbacks from non-participating parcels, structures, and rights of way
- Fencing and other screening measures to preserve viewsheds of cultural or historic sites, scenic byways, historic corridors, current or proposed bike trails, or other recreational resources in Greene County
- Land use principles, including preservation and development of agricultural lands
- Lighting
- Construction practices, access, and traffic management, including but not limited to maintenance and repair of roadways
- Drainage and stormwater management, including field tile locating, maintenance, and repair
- Decommissioning plans
- Economic impact
- Wildlife and vegetation management

Additionally, the Greene County Board of Commissioners may be interested in pursuing cross-examination of witnesses on additional issues as the record is supplemented and as other intervenors' witnesses are identified, and as further testimonial or documentary evidence is presented by the parties, and the Greene County Board of Commissioners respectfully requests to reserve its right to address such issues.
