NOTICE OF DEPOSITION

Pursuant to Ohio Adm.Code 4906-2-18(E), please take notice that on March 3, 2022 commencing at 9:00 a.m., Kingwood Solar I LLC (“Kingwood Solar”) will take the deposition of the Greene County Board of Commissioners concerning the following matters:

1. Any communication with, to or from any representative or employee of the Public Utilities Commission of Ohio and/or the Ohio Power Siting Board regarding the passing of a resolution related to solar development in Greene County, Ohio;
2. Any communication with, to or from any representative or employee of the Public Utilities Commission of Ohio and/or the Ohio Power Siting Board regarding the passing of a resolution related to the proposed Kingwood Solar Project in Greene County, Ohio;
3. Any communication with, to or from any representative or employee of the Public Utilities Commission of Ohio and/or any representative or employee of the Ohio Power Siting Board occurring between October 1, 2021 and October 29, 2021; and
4. Any communication with, to or from any representative or employee of the Public Utilities Commission of Ohio and/or the Ohio Power Siting Board regarding the proposed Kingwood Solar Project.

The Greene County Board of Commissioners is instructed to choose one or more of its officers, agents, employees, or other persons duly authorized to testify on its behalf as to matters known or reasonably available to the Greene County Board of Commissioners, and to set forth,

for each person designated, the matters on which he or she will testify. The deposition will be conducted at the offices of Vorys, Sater, Seymour and Pease LLP, 52 E. Gay Street, Columbus, Ohio 43215 or via videoconferencing software as agreed by the Greene County Board of Commissioners and Kingwood Solar, before a person authorized to administer oaths in Ohio. The deponent will appear at the offices of Vorys, Sater, Seymour and Pease LLP, 52 E. Gay Street, Columbus, Ohio 43215, or virtually, at the designated time. Pursuant to Ohio Adm.Code 4906-2-18(N) and Ohio Adm.Code 4906-2-19, the deponent shall produce, at least two hours prior to the taking of the deposition, any documents evidencing, relating to or referring to any of the communications listed above in matters 1 through 4.
