17 18	Q.1.	Please state your name and home address.	
19	A.1.	Angie Hanna. I live at 3251 Wilberforce Clifton Road, Cedarville, Ohio 45314 with my	
20	husba	nd Jed Hanna and two of our children.	
21	Q.2.	On whose behalf are you offering testimony in this case?	
22	A.2.	I am offering testimony on behalf of Intervenors Citizens of Greene Acres, Inc., Jenifer	
23	Adam	s, P. Chance Baldwin, Jacob Church, Verity Digel, Jed Hanna, Krajicek Family Trust,	
24	James	Joseph Krajicek, Karen Landon, Nicole Marvin, Chad Mossing, Karen Mossing, Nicholas	
25	Pitstic	k, Kyle Shelton, Marlin Vangsness, Jean Weyandt, and Jerald Weyand. My testimony will	
26	refer t	o the Citizens for Greene Acres, Inc. as "CGA."	
27	Q.3.	Are you a member of CGA?	
28	A.3.	Yes.	
29	Q.4.	Is any member of your family an intervenor in this case?	
30	A.4.	Yes, my husband Jed Hanna is an intervenor.	
31	Q.5.	What is your occupation?	
32 33	A.5.	I have been employed as a registered nurse at a local hospital for 22 years.	

1	Q.6.	Are you familiar with the location that has been proposed for the Kingwood Solar
2		project?
3	A.6.	Yes. I have become familiar with the proposed project area by reviewing maps of the
4		project area in the application filed with the Ohio Power Siting Board. In my testimony, I
5		will refer to the Kingwood Solar project as the "Project" and the land proposed for the
6		site of the Project as the "Project Area."
7	Q.7.	Do any members of your immediate family own property adjacent to the Project
8		Area?
9	A.7.	Yes, the property of almost five acres at 3251 Wilberforce Clifton Road at which Jed
10		Hanna and I live is adjacent to the Project Area. My testimony will refer to the property
11		at 3251 Wilberforce Clifton Road as the "Residential Parcel." Jed owns this property.
12		Attached Exhibit A, which is a photograph that I took on May 7, 2021, accurately depicts
13		the front of our house, the front part of our yard, and the driveway to the house. The
14		Project Area is adjacent to the entire north side and the entire west side of the Residential
15		Parcel. A portion of the Project Area to the west of our property is shown as a black field
16		on the left side of Exhibit A.
17	Q.8.	Do any members of your immediate family own any other property that is near the
18		Project Area?
19	A.8.	Yes, Hanna Family Properties LLC owns a 2.6-acre parcel at 3265 Wilberforce Clifton
20		Road, which includes a house occupied by a renter. My testimony will refer to this
21		property as the "Rental Property." The Rental Property is located on the southern
22		boundary of the Residential Parcel.
23	Q.9.	Have you been involved in decisions made by Hanna Family Properties LLC?

1	A.9.	Yes, Jed and I collaborate on the decisions made by Hanna Family Properties LLC.
2	Q.10.	Did you know about the Project at the time the Rental Property was purchased?
3	A.10.	Yes.
4	Q.11.	If that is the case, why was this property purchased?
5	A.11.	The prior owner of the Rental Property had sold the Residential Parcel to Jed Hanna and
6		was allowing us to use the driveway on the Rental Property for access between our house
7		and Wilberforce-Clifton Road. When the Rental Property was offered for sale, Jed and I
8		decided to buy the property through Hanna Family Properties LLC so that we would not
9		lose the access from our house to Wilberforce-Clifton Road.
10	Q.12.	What are the distances between your house and other things on the Residential
11		Parcel and the Project Area?
12	A.12.	The Project Area is 70 feet from the western wall of our house and 41 feet from the
13		northern wall of our house. The Project Area is 20 feet from our barn, 37 feet from our
14		pool, and 30 feet from our well.
15	Q.13.	Describe the yard on the Residential Parcel.
16	A.13.	The house is surrounded on four sides with lawn. The lawn on the west and north sides
17		of the yard extends to the edge of the property, abutting the Project Area. An
18		aboveground pool is located in the west lawn, 37 feet from the property boundary that
19		abuts the Project Area. A porch is attached to the front of the house. A large deck is
20		located on the west side of the house. A playground set and a sandbox are located south
21		of our house with a view of the Project Area to the west.
22	Q.14.	Describe your views of the Project Area from the house and yard at the Residential

23 Parcel.

1	A.14.	My family and I have clear and close views of the crop field in the Project Area from the
2		yard west and north of our house, from the porch in front of the house, from the deck on
3		the west side of our house, and from the windows on the north and west sides on the first
4		and second floors of the house. Attached Exhibit B is a true and accurate copy of a
5		photograph I took from the front porch of our house showing the Project Area to the
6		west, which is the field depicted starting beyond the grass of our yard. Attached Exhibits
7		C through F are true and accurate copies of photographs I took through windows on the
8		first and second floors of our house showing our grassed west yard and the Project Area
9		immediately behind the grass starting at the edge of the field. Attached Exhibits G
10		through I are true and accurate copies of photographs I took through windows on the first
11		and second floors of our house showing our grassed north yard and the Project Area
12		immediately behind the grass starting at the edge of the field. I took the photographs in
13		Exhibits B through I in 2021 or 2022.
14	Q.15.	What if any recreational activities are conducted in your yard at the Residential
15		Parcel?
16	A.15.	My family and I enjoy sitting and relaxing on the front porch and the deck. We have
17		some meals on the deck. We entertain friends and family for outdoor parties in the fall
18		and host many swimming parties in the summer. We have recreational activities in our
19		yard, including flying kites and riding four-wheelers, a golf cart, and a go-cart. Our
20		children play in the yard, including in the playground set and sandbox.
21	Q.16.	Have you seen any birds in your yard at the Residential Parcel or in the Project

22 Area adjacent to this yard?

1	A.16.	Yes. I occasionally see Great Blue Herons. On one occasion last summer, I saw two
2		Bald Eagles sitting in the Project Area north of our yard and have seen them flying over
3		the Project Area. Ducks have nested near our yard. I have seen Sandhill Cranes flying
4		over our property.
5	Q.17.	Does this conclude your direct testimony?
6	A.17.	Yes.


