**SUPPLEMENTAL TESTIMONY OF JEFF EWRY  
FOR BOARD OF TRUSTEES OF  
CEDARVILLE TOWNSHIP, GREENE COUNTY, OHIO**

- 1    Q-1    Please state your name, title and business address.
- 2            A-1    My name is Jeff Ewry. I am the chair of the Board of Trustees of Cedarville
- 3            Township in Greene County, Ohio. The township office address is 78 N. Main Street,
- 4            Cedarville, OH 45314.
- 5    Q-2    Did you previously present direct testimony in this proceeding?
- 6            A-2    Yes. I presented direct testimony in this proceeding that was originally filed on
- 7            February 25, 2020 and refiled with the Board's permission on March 1, 2022.
- 8    Q-3    On whose behalf are you offering testimony?
- 9            A-3    I am testifying on behalf of the Board of Trustees of Cedarville Township.
- 10   Q-4    What is the purpose of your supplemental testimony?
- 11            A-4    To revise certain statements contained in my Direct Testimony and to introduce
- 12            and explain the revised Public Comment Analysis that is attached to this Supplemental
- 13            Testimony as Cedarville Township EXHIBIT 2C.

1 Q-5 What additional statements would you like to make regarding the attached Cedarville  
2 Township EXHIBIT 2C?

3 A-5 The answer to Question 6 of my Direct Testimony should read as follows.

4 I created an EXCEL spreadsheet that tracked all comments made at the November 15,  
5 2021 public hearing held in Xenia, Ohio, and comments that were posted on the Ohio  
6 Power Siting Board website. Our Board then used the Greene County Auditor's online  
7 records to verify addresses for commenters residing in Greene County. When those  
8 searches were inconclusive, we asked residents in the area if they knew where certain  
9 commenters resided. In any event, the address listed on the spreadsheet for each  
10 commenter is sourced either from the comment itself, or from a county auditor's public  
11 records.

12 The spreadsheet is capable of sorting on different columns of information so that  
13 the identity and number of commenters from each of the three intervenor townships  
14 (Cedarville, Miami & Xenia Townships) can be identified and studied. We paid special  
15 attention to the comments of Cedarville Township residents regarding the Project. We  
16 also tried to identify which of the commenters have a financial stake in the Project  
17 approval (lease holders and family of lease holders) and other commonalities shared by  
18 commenters who express support for the Project but reside outside of the three townships.  
19 I am confident that the spreadsheet reflects all comments made at the public meeting and  
20 posted on the Ohio Power Siting Board website. The information and statements  
21 contained in the last column of the spreadsheet titled "Notes" is based on my personal  
22 knowledge obtained by living in the area for many years and through the Trustees'  
23 independent research.

1           The spreadsheet of public comments is attached to this Supplemental Testimony  
2           as Cedarville Township's EXHIBIT 2C. In summary, for commenters residing in  
3           Cedarville Township, all 33 non-participating commenters oppose, and 3 participating  
4           commenters support the Application. For commenters residing within the three affected  
5           townships (Cedarville, Miami & Xenia), 81 non-participating commenters oppose, 2 non-  
6           participating commenters support, 8 participating commenters support, and 4 relatives of  
7           participating parties support the Application. In total, as of February 28, 2022, 121  
8           commenters oppose, and 57 commenters support the Application.

9   Q.6   Does this conclude your testimony?

10   A-11   Yes.
