Dear Attorney Examiners Schabo and Williams,

Pursuant to the June 16, 2021 Opinion and Order in the above-referenced proceedings, which adopted and approved the October 23, 2020 Stipulation and Recommendation ("Stipulation") filed in the same dockets, The Dayton Power and Light Company d/b/a AES Ohio committed to work with Natural Resources Defense Council ("NRDC") to evaluate and pursue project(s) to be located within and in neighborhoods surrounding Wright-Patterson Air Force Base that increase energy resiliency ("Resiliency Project(s)"). AES Ohio submits this status report regarding the progress of this joint effort. Stipulation, \P 16(a)(iv).

Pursuant to Paragraph 16(a)(ii) of the Stipulation, AES Ohio and NRDC identified the Wright-Patterson Regional Council of Governments ("WPRCG") as the recipient of the Resiliency Project(s) Grant, and on February 2, 2022, AES Ohio executed an agreement to provide a shareholder contribution of \$250,000 to WPRCG to fund the Resiliency Project(s). AES Ohio has since disbursed those funds to WPRCG.

Consistent with Paragraph 16(a)(iii) of the Stipulation, AES Ohio and NRDC will continue to coordinate planning efforts, including those designed to leverage federal funding for clean energy that would support the Resiliency Project(s), evaluate and purse federal funding that may be available now or in the future to support the Resiliency Project(s), evaluate opportunities using AES Ohio's existing General Services Administration area-wide agreement, and engage other public utilities that serve Wright-Patterson Air Force Base and surrounding communities to identify potential energy resiliency investment partnerships. AES Ohio will report on these efforts in its Grid Mod Implementation Update Group.
