**Subject:** Kingwood Solar staff report has been filed, recommends denial

Given your interest in the Kingwood Solar project, I want to make you aware of the project's latest development.

This afternoon, we filed the staff report, one of the major steps on the Ohio Power Siting Board's review process. The report contains the OPSB's technical staff's review of Kingwood's application to construct a utility scale solar facility. Following a review of the application, Staff recommends that a certificate not be issued for the proposed Kingwood facility. Specifically, Staff recommends the Board find the applicant has failed to establish whether the facility will serve the public interest, convenience and necessity as required under RC 4906.10(A)(6).

Looking ahead, the public hearing has been scheduled for Nov. 15 at 6:00 p.m. in the Greene County Expo Center, Assembly Hall, 120 Fairground Rd, Xenia.

The Evidentiary hearing will be held at 10 a.m. on Dec. 13 in Hearing Room 11-A at the Public Utilities Commission of Ohio, 180 E. Broad St., Columbus.
