**NOTICE OF INTERVENTION AS A
PARTY OF THE
BOARD OF TRUSTEES OF XENIA TOWNSHIP, OHIO**

On April 16, 2021, Kingwood Solar I LLC filed an application with the Ohio Power Siting Board for a Certificate of Environmental Compatibility and Public Need for the Kingwood Solar 175 MW Solar Electric Generating Facility in Greene, County, Ohio. Pursuant to Ohio Revised Code Section 4906.08 and Ohio Administrative Code Rule 4906-2-12, the Board of Trustees of Xenia Township, Ohio, files notice of its intervention in the above captioned proceedings and states as follows:

1. The Board of Trustees of Xenia Township, Ohio is the duly elected body authorized to act for Xenia Township and has taken the required action to intervene, as certified by the attached resolution taken from the meeting minutes of Xenia Township Trustees regular meeting of February 4, 2021. 2. That the proposed facility, as reflected in the application, is to be located at least in part in Xenia Township, Ohio.
3. The Board of Trustees of Xenia Township, Ohio intends to intervene because it has extensive interest in the proposed project and proceedings as the elected representatives of the citizens of Xenia Township, Ohio who will be impacted by the proposed project.
